



Waiver of Risk and Release of Liability

1. I have read, understand and agree to follow the policies and procedures of Pet Home Support.
2. I am fully aware of the Rates and Fees charged by Pet Home Support, and agree to pay in full upon check-out of my pet.
3. I understand that I am solely responsible for any harm caused by my pet during its stay with Pet Home Support.
4. I will ensure that my pet is currently vaccinated and I agree to provide proof of current vaccinations if requested.
5. I represent that my pet is in all respects, does not currently have (and has not had within the prior 10 days) any communicable diseases and is on flea and tick prevention. My Pet does not suffer from any disability, illness, or condition which could affect it, other pets or employee safety at Pet Home Support. In admitting my pet, I understand that Pet Home Support has relied on this representation.
6. I understand that there are risks involved in having my pet cared for by Pet Home Support. In the event of illness or injury, I authorize Pet Home Support to take my dog to the nearest vet considered to be the most suitable by Pet Home Support. I agree to pay all vet care required or advised, in the opinion of the vet, to the amount of \$500. If the required care will exceed that amount, I know that Pet Home Support will try to contact me at the telephone numbers I have given. If they cannot reach me, Pet Home Support is authorized to use their best judgment in deciding whether to go ahead with any form of treatment recommended by the vet, whether the cost of such treatment exceeds \$500 or otherwise, and I agree to pay for all such care.
7. I give my permission to Pet Home Support to take pictures of my pet while in residence with Pet Home Support and to post these pictures on the Pet Home Support website and social network pages, such as Facebook and Twitter.
8. I recognize that there is an inherent risk of injury, illness or death in any environment associated with numerous pets. I also recognize that such risks include, without limitation, injuries, illnesses or death resulting from stress, fights, rough play and contagious diseases. Knowing these inherent risks and dangers, I understand that Pet Home Support cannot be held responsible for any injury, illness, death or damage caused to or by my pet and that I am solely responsible. **THEREFORE, I DO HEREBY RELEASE, INDEMNIFY AND HOLD HARMLESS PET HOME SUPPORT FROM AND AGAINST ANY CLAIM, LIABILITY OR CAUSE OF ACTION, INCLUDING ANY CLAIM, LIABILITY OR CAUSE OF ACTION RELATING TO THE NEGLIGENCE OF ANY PET HOME SUPPORT, ITS OWNERS, AGENTS AND/OR EMPLOYEES, RELATING DIRECTLY OR INDIRECTLY TO ANY CLAIM, CAUSE OF ACTION OR LIABILITY THAT I MAY HAVE OR ASSERT AGAINST PET HOME SUPPORT, ITS OWNERS, AGENTS AND/OR EMPLOYEES, RELATING TO MY PET'S STAY AND/OR PARTICIPATION IN ACTIVITIES WHILE WITH PET HOME SUPPORT.**
9. I certify that I have fully disclosed any and all information regarding my pet's behavioral issues or history of biting.
10. I expressly agree to be held responsible for any damage to property (i.e., lodging area, fencing, walls, flooring, etc.) or other cost incurred by my pet.
11. I expressly agree to be held responsible for medical costs due to human injury caused by my pet.
12. I understand that if my dog displays aggressive behavior, that for the safety and health of my dog and others, he/she will be confined to an enclosure or be muzzled for the remainder of his/her stay with no offset or deduction in price.
13. I understand that "pet" may refer to one or more than one pet.
14. I REPRESENT THAT I HAVE MADE FULL DISCLOSURE AND HAVE READ, UNDERSTAND AND ACCEPT THE TERMS AND CONDITIONS STATED IN THIS AGREEMENT, AND ACKNOWLEDGE THAT THIS AGREEMENT SHALL BE EFFECTIVE AND BINDING UPON THE PARTIES AND THEIR RESPECTIVE SUCCESSORS AND ASSIGNS.
